

Tonawandas USBC Bowling Scholarship Fund Instructions to Applicant

ELIGIBILITY RULES:

Any graduating high school senior is eligible to receive a scholarship, providing the student meets the following requirements:

- A. Files an application furnished by the Scholarship Fund Committee, giving complete information as required thereon, before March 31, 2010. Application is to be filed with Susan Reinke of the Scholarship Fund Committee.
- B. Has unimpaired amateur standing in bowling.
- C. Is a current member in good standing of a Tonawandas USBC Junior Association sanctioned league.

APPLICATION PROCEDURES:

Step 1 – Fill out application entirely.

Step 2 – Write an essay of at least 100 words stating your specific college and future plans. Judging will be based on the inclusion of specific plans, clarity, organization and logic.

Step 2 – Give your league coach your essay, the completed application form, Coach's Evaluation and Data Sheet and a stamped addressed envelope addressed to Susan Reinke of the Scholarship Fund Committee. Ask your coach to fill in the Evaluation and Data Sheet entirely then mail all forms to the committee by March 31, 2010.

Step 4 – Give the School Official/Counselor's Evaluation Sheet to one of your teachers or your school counselor along with a stamped envelope addressed to Susan Reinke. Ask your teacher or counselor to fill in the form and mail to the Committee before March 31, 2010.

Step 5 – Check with your league coach and teacher or counselor by March 24, 2010 to make sure all the application papers have been mailed. Thank them for their help and cooperation.
