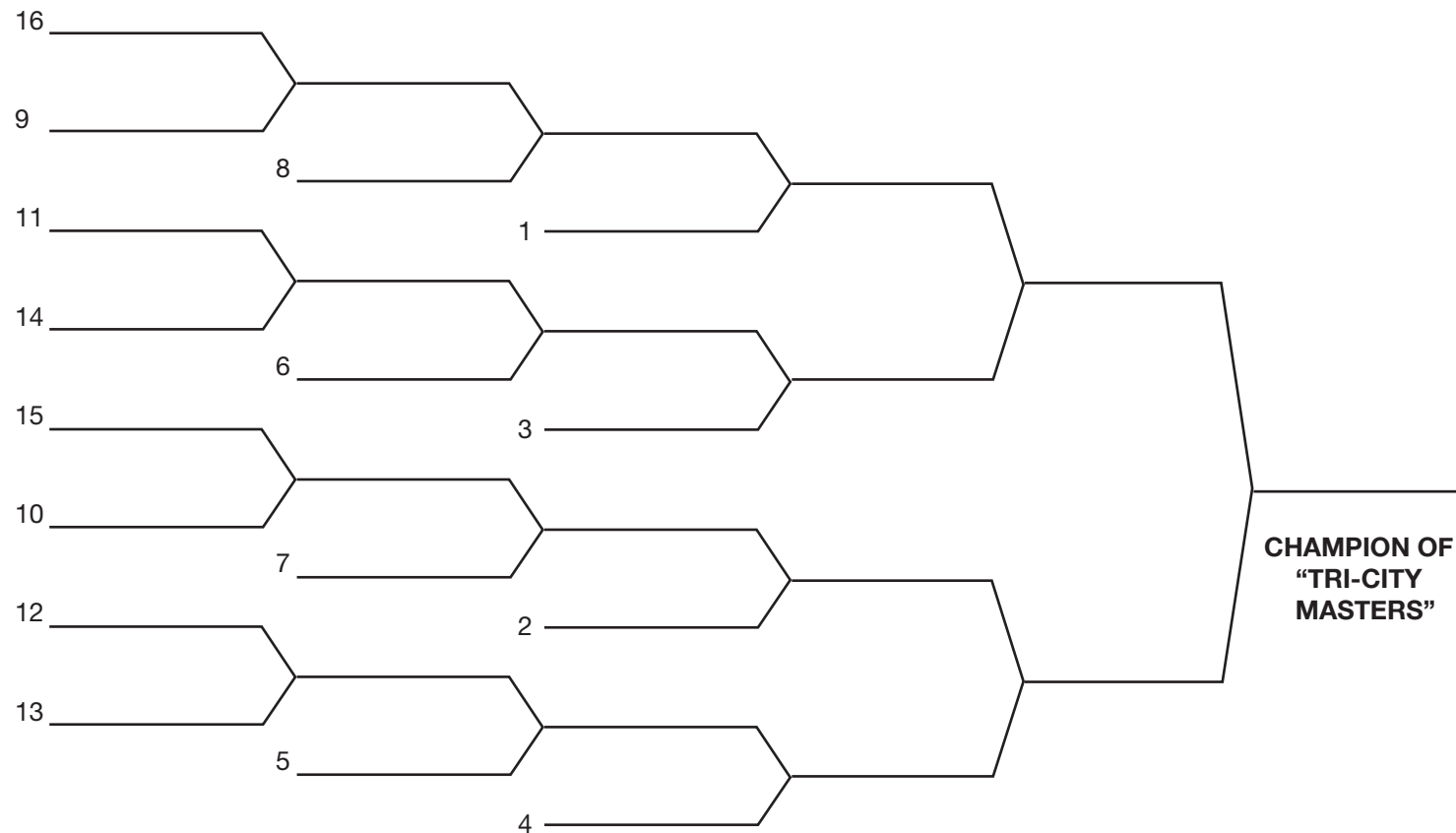

## SCOPE OF THE TOURNAMENT:

The Tri-City Masters Championship has been designed to combine three former tournaments: The Tonawandas' Herbert E. Burns Match Game Championship, the Lockport Allie Brandt Memorial Match Play Championship and the Niagara Falls Masters Tournament. This tournament will be rotated among the (3) Associations, acting as a host for the year. So, to maintain separate identities and preserve historic values, the highest finishing entrant from each Association will be declared that Association's champion. This champion designation carries with it: \$300.00 cash prize, as well as other champion values such as Association yearbook and record book recognitions. The runner-up from each Association receives a \$100.00 cash prize. This tournament is operated within the guidelines and sanctioning of the USBC., and operated by the 3 local USBC associations.

Each of the (3) Associations shall provide a championship trophy for their highest finisher who will be recognized as the Association Champion. The tournament directors make no claims about lane condition scorability. Charitable donations and Association-run fund raisers are allowed. Please be generous.

## ELIGIBILITY RULES

This tournament is open to all USBC members, male and female, who have not won a PBA or PWBA national title in the past 10 years. Additionally, any participant who is not a member of one of the sponsoring associations, Tonawandas, Lockport, or Niagara Falls, must pay a local membership fee of \$11.00 to the host association (Lockport) in order to bowl in the tournament.

## DRESS CODE

- \* All participants must wear a collared shirt or a bowling style shirt for both the qualifying and match play rounds, plus trousers (NO SHORTS). Names and sponsor names are acceptable.
- \* DRESS TROUSERS ARE REQUIRED FOR THE MATCH PLAY PORTION OF THIS TOURNAMENT.
- \* Corduroys, denims and jeans will be allowed in the qualifying round only. Sweat pants and hats are not permitted.
- \* A "Sergeant-at-Arms" appointed by the Directors may be in place and will have final authority regarding disputes about suitable attire; which may include immediate disqualification and forfeiture of the entry. Please do not attempt to stretch these rules.

## RULES

1. After the Early Bird entry closing date, entries are not refundable, but may be transferred to another qualified bowler. Personal checks accepted, but are subject to a \$30 service charge, if returned.
2. All entrants shall bowl a (6) game qualifying round commencing precisely at 11:00 AM on February 10th. Late arriving bowlers shall receive zero for every frame missed (no refunds).
3. Lane assignments and pairings will be determined by the tournament directors. Bowlers shall be allowed 15 minutes of open practice commencing at 10:45 A.M. Bowlers may cross lanes during this practice period. Following several announcements, competition will begin immediately with **NO** further practice.
4. The 6-game qualifier shall include movement across all of the lanes to be used. Bowlers shall move after each game. There shall be no practice between games.
5. Total pinfall from the 6-game qualifier shall determine the TOP 16 qualifiers for the match play round.
6. In the event of a tie for 4th place, 8th place, or 16th place in the qualifier, a one-game roll-off among those tied will determine the final placement. This roll-off will take place immediately following the qualifying round on a pair of lanes selected by the tournament directors. In the event the roll-off ends in a tie, see rule 11.
7. In the event of a tie for any other position from the qualifier, the higher individual game of the tied bowlers, shall be utilized to determine the seed positions in the match play grid on the back page.
8. Lane assignments for the match play segment shall be prominently displayed prior to commencement of the tournament. Practice for the first round of match play shall consist of 10 minutes on your starting pair. The (8) seeded players will have a practice pair available. Subsequent rounds' practice will consist of 2 balls on each of your starting lanes.
9. The match play finals will consist of two-game, single elimination matches. The top 4 qualifiers will receive two-round byes, while qualifiers 5 thru 8 will receive one-round byes. Pairings for the first round of match play are as follows: No. 9 vs No. 16, No. 10 vs No. 15, No. 11 vs No. 14, No. 12 vs No. 13. All match play shall take place on February 11th commencing at 11:00 AM.
10. The bowler assigned to the left lane shall start each match. The 2nd game of each match will start on the lanes on which each bowler finished the first game of the match.
11. In the event of a tie match, a 9th and 10th frame roll-off shall commence immediately on the same pair of lanes with the participant who started the match on the left lane doing so again for the 2-frame roll-off. If a tie results again, this rule will be repeated until a winner is determined.
12. In the event that the highest **finishers** from one of the Associations cannot be determined, (if 2 or more are eliminated in the same round) a one-game roll-off among the contestants shall take place to determine the Association champion and runner-up; and the corresponding Association-paid awards. In the event the roll-off ends in a tie, see rule 11.
13. In the event that a bowler is not able to participate in the match play portion, he shall receive zero pins for each frame missed, and ultimately forfeit his match. There shall be **NO** alternates.
14. In addition to the prize money won, the 2018 Tri-City Masters Champion will receive a free entry into the 2019 Tri-City Masters Tournament. This free entry will be forfeited if the bowler fails to bowl, and it cannot be transferred to another bowler.
15. One rerack per game is allowed. Additional reracks **must** be authorized by an Association Director. The penalty will be zero for the frame in which the unauthorized rerack took place!
16. In the event that **NO** bowlers from a given Association qualify in the TOP 16, the ranking of the 6-game qualifier shall be utilized to determine the Association paid awards.
17. The decisions of the Tournament Directors will be final in resolving any disputes or dealing with any unforeseen situations or emergencies; unless an appeal is made in accordance with USBC Rule #329.
