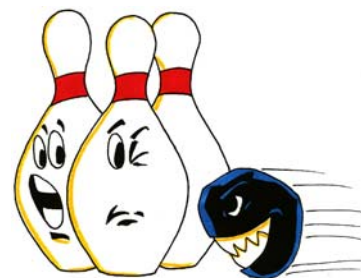

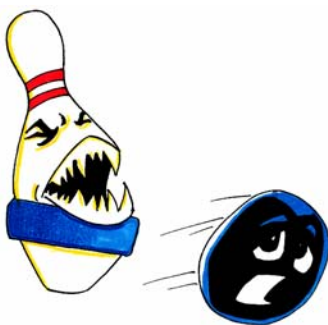

TOURNAMENT RULES:

1. Youth members of the Tonawandas USBC Association are eligible to enter.
2. Entries will be accepted on a first-come first-served basis. Bowlers will be notified by phone if no vacancy exists.
3. Entries will be accepted on a first-come, first-served basis. **ENTRY FEES MUST ACCOMPANY THE ENTRY FORM. INCOMPLETE ENTRIES WILL BE RETURNED.**
4. Paid entries, \$8 per bowler, **must be submitted by 2PM Saturday, March 20, 2010.**
5. Bowlers must use highest current USBC average as of February 19, 2010 (minimum 9 games).
6. If no current USBC average, bowler will use highest 2008-2009 USBC average (minimum 9 games).
7. If a bowler does not have a current year or 2008-2009 USBC average then the bowler will bowl scratch in Division A.
8. Bowlers will compete in one of the following divisions:

	<u>BOYS</u>	<u>GIRLS</u>
Division A	141 avg & over	126 & over
Division B	101 – 140	101 – 125
Division C	100 & under	100 & under
9. Handicap will be 100% of 225 for all bowlers.
10. No re-entries allowed.
11. Bowlers are asked to report no later than **30 minutes before** their starting time.
12. Foul detecting devices will be in operation.
13. All USBC Rules will be in effect.
14. Awards will be given in all divisions for first place scratch winner as well as the top three (3) series with handicap. Awards will also be given in all divisions for All Events first place scratch winner as well as the top three (3) All Events with handicap.
15. The decision of the Tournament Director will be final in resolving all disputes or dealing with any unforeseen situations or emergencies, unless an appeal is made in accordance with USBC Rule #329.
